# Appalachian Mountain Club Ponkapoag Camp Reservations



**Facilities**: Large cabins sleep 5-6; medium, 4-5; small cabins sleep 2-3; there are also two single-family tent sites. No electricity, running water, or trash receptacles. Pit toilets. Cabins come with furniture and (for cold weather rentals) wood burning stove. Bring bedding, cook stove, dishes, etc., and drinking water. Tent sites and many cabins have outdoor fireplaces; there are also two common fireplaces. Firewood is available for purchase during the off-season.

**Trash, Pets, Boats, and Other Camp Rules**: To protect the environment as well as the peace and safety of fellow campers, campers are expected to follow camp rules (<u>https://ponkapoagcamp.org/rules/</u>) and rules governing the state's Blue Hills Reservation. Camp has no facilities for trash disposal; campers must carry out all their trash. Ponkapoag is a pet-friendly camp. To keep our camp safe and enjoyable, we ask that you carefully review our rules related to pets. Pets that disrupt camp due to excessive barking or lack of supervision will be asked to leave. Campers may bring small boats that can be carried manually to the water. No gas engines. In accordance with DCR policy, no person may smoke or vape in or on any Ponkapoag buildings or structures including porches or in designated swimming, wading areas, other public gathering areas, or areas posted as prohibited, at the managers discretion.

**Summer Season**: The lodge – with electricity for a few hours a day – and waterfront are open from June 26<sup>th</sup> through Labor Day. During the summer season, rentals are by the week only (except tent sites), and are limited to 3 weeks, not counting last-minute fill-ins (to be on the fill-in waiting list, leave a deposit with the summer manager.) For the final week of summer, campers who volunteer to help close camp can stay through Labor Day at no extra cost.

**Rental Requirements**: Renters must be at least 21 years old and have a primary residence other than camp. All persons, including persons under 21 years old, staying at the camp must be registered. Anyone who is not listed on the reservation form will not be allowed to stay overnight at camp. Large groups cannot be accommodated.

**Rental Arrival/Departure Time and Procedures**: Summer rental check in starts at 4:00 PM on Sunday. Check out is 11:00 am on Sunday. For off-season rentals, please call the manager (781-961-7007) on the morning of your arrival to get the gate lock combination and to inform the manager of your estimated arrival time. At check-out, campers should follow cleaning procedures as posted in cabins and drop cabin key off in box outside manager's office.

**Deposit**: Reservations are only accepted with a deposit. Cancellations with 30 days' notice are eligible for a 50% refund. Cabins must be paid in full prior to arrival at camp. Any remaining balance on arrival must be paid before cabin key can be turned over. Campers will be charged for the full rental period regardless of late arrival or early departure. In cases of severe weather or extreme emergencies, dates can be rescheduled without penalty. For summer rentals, reservations postmarked by April 30 get firstconsideration.

**Priority Rentals for Volunteers**: Renters who have worked 15 volunteer hours over the previous year get first priority for summer reservations. Work parties are scheduled throughout the year; please email <u>ponkapoagfacilities@outdoors.org</u> to be added to our email list for announcements and let the manager know if you would like to volunteer to clean up, fix something, or help out during your stay.

## **COVID-19 Guidelines**

#### Health Considerations

- 1. Masks are welcome but not required at camp
  - a. AMC recommends guests wear a mask in a High Level Community COVID-19 areas, regardless of vaccination status, per CDC guidelines. If you are in an area of Low or Medium Community COVID-19, masks are welcome, but not required.
  - b. As of March 2022, Ponkapoag Camp is in a Low Risk county. Campers should check the current risk level before arrival at camp: <u>https://www.cdc.gov/coronavirus/2019-ncov/your-health/covid-by-county.html</u>
- 2. Campers must be able to answer 'no' to the questions below on the day of their arrival at camp. Campers who cannot answer 'no' **must not come to camp**.
  - a. Have you exhibited any COVID-related symptoms in the past fourteen days?
  - b. Have you had close contact in the past fourteen days with anyone actively experiencing COVID symptoms?
  - c. Are you currently under a quarantine or stay-at-home order?
- 3. Development of symptoms
  - a. If a camper feels sick and/or develops COVID-related symptoms while at camp:
    - i. Notify manager immediately
    - ii. Depart camp as soon as possible
    - iii. All unvaccinated campers who stayed in the same cabin as the sick camper or who at any point came in close contact with the sick camper must also depart camp as soon as possible
  - b. COVID-19 symptoms can be found on the CDC website
- 4. Vaccination FAQs
  - a. AMC follows science and guidance from the <u>CDC</u>
  - b. Vaccination Status: AMC does not discriminate on the basis of vaccination status
  - c. Vaccination status cannot be used as criteria for attendance at or participation in camp activities
  - d. Camp manager shall not ask about vaccination status for campers unless managing a situation with individuals who were in close contact with a sick camper
  - e. Requirements to comply with all required COVID health and safety practices as described in the current Phase or as mandated by government agencies and land managers remain in place regardless of vaccination status

#### Protocols – Cabins, Site, Lodge, Outhouses and porta-potties

- 1. Cabins, lodge, outhouses and porta-potties are cleaned in accordance with <u>CDC</u>, AMC and State requirements
- 2. Hand sanitizer and basic cleaning supplies are provided by camp
- 3. Any camper who develops symptoms within seven (7) days of departing camp must notify the manager immediately

#### Protocols – Waterfront / Dock / Swimming area (summer only)

1. Lifeguard has the authority to enforce Covid-related rules at the waterfront/dock/swimming area. Campers who do not respect the lifeguard's requests will be required to leave the area for the remainder of the day. Campers who repeatedly disregard the lifeguard's authority will be banned from the area for the remainder of their stay.


